CHSCPR is the only healthcare coalition (HCC) for the City of Chicago and EMS Region 11 that is funded by the Chicago Department of Public Health (CDPH). The other 10 EMS Regions in Illinois, each with a local HCC, are funded by the Illinois Department of Public Health.




MEMBERSHIP

In April 2023, the HCC approved an amended Governance Charter. Key updates included a distinction between Members and Supporting Members; At Large Member definition expansion; addition of the Clinical Advisor role; clarification of Committee Chair expectations; and a clear delineation between Emergency Medical Services and the Chicago Fire Department.

TRAINING

Identifying and assessing the preparedness to respond to an emergency by developing the necessary knowledge, skills, and abilities of HCC member's workforce.

Courses Offered

HCC members participated in training and development initiatives covering emergency communications, use of response software, and emergency care.

Twenty-five clinicians attended an Advanced Burn Life Support (ABLS) course and became certified to care for burn patients within the acute phases of injury. ABLS courses are certified through the American Burn Association (ABA).

Hospitals, long-term care facilities, and dialysis centers took part in Juvare EMResource™ and EMTrack™ online training sessions. Basic EMResource™ and EMTrack™ training included logging in, navigating, setting notification preferences, responding to events as well as basic patient entry. Advanced courses in EMResource™ and EMTrack™ taught users facility and resource management, forms, reports, and user management. Eighty-two partners were trained.

A two-day in person Amateur Radio (HAM) training with Licensing Examination was offered to emergency responders. Attendees learned basic regulations, operating practices, and identifying actions and activities for when a HAM radio would be used during emergency responses. Attendees who passed the licensing examination were supplied with HAM radios.



Stop the Bleed®

Hospital partners ventured into the community to provide Stop the Bleed® training to more than 470 people, using training supplies provided by the HCC. Several sessions were conducted at elementary and high schools.

In June 2023, three one-day hospital decontamination operations-level trainings were provided. The training included hazard identification, incident command system/decontamination procedure overview, practical skills application (PPE and decontamination equipment), equipment setup, and implemention of an emergency decontamination operation.

EXERCISE

Conducting coordinated exercises that highlight applicable regulatory and compliance issues that assess the HCC's readiness by identifying resource needs and gaps before, during, and after an emergency.

The HCC provided its members with a functional exercise on June 1, 2023 with the scenario of a complex coordinated terrorist attack.

The functional exercise afforded over 500 healthcare partners the opportunity to activate incident command, implement facility emergency operation plans, and conduct incident action planning related to a mass casualty incident and security threat. Participating facilities exchanged information over a variety of communication mechanisms to include resource coordination with the CDPH Public Health Emergency Operations Center (PHEOC). Facilities activated their finance and administrative section to perform functions related to cost tracking for the incident response.

Organizations operationally addressed facility security and contininuity of operations in a rapidly evolving security threat situation and mass casualty incident (MCI).

Operationally, hospitals received, triaged, and addressed treatment needs for MCI patients.

The HCC also developed an Active Shooter Recovery Tabletop Exercise that members can access via the HCC website (chscpr.org). The exercise is on-demand and can be conducted at any time along with a previously developed weather-related scenario.



INFORMATION SHARING

The coordination and ability to conduct multijurisdictional, multidisciplinary exchange of public health and medical-related information and situational awareness between the healthcare system and partners.

Communication

HCC members and stakeholders received over 175 informative emails from chscpr@team-iha.org regarding protests, rallies, marches, weather conditions, and special events. Additionally, these emails included essential details on coalition meetings, training opportunities, and radio drills. Furthermore, the emails offered guidance and resources and addressed inquiries from partners such as ASPR, CDPH, IDPH, and others.

There are over 775 contacts in the HCC distribution list.

The HCC's Communications Annex was updated to include current key contact and communications information; recent improvements and tools in the EMResource™ system (e.g. the Document Library and ICS 213 Resource Request form); and, removal of obsolete equipment and processes.

All members of the HCC were asked to access and complete the updated CHSCPR.org member registration form in Spring 2023. This process has and will continue to grant the appropriate access to the secure CHSCPR.org Member Portal; update the HCC's distribution list; and, increase traffic to and familiarity with the website's many resources. Within the Member Portal, the Emergency Preparedness Contacts directory has also been updated and reorganized based on new CHSCPR.org member registrations; a search function has been added; and, resources and tools for members are consistently refreshed (in addition to the website's public-facing news and events sections).

Eight planned STARCOM21 and HCRS radio drills occurred from July 2022 through June 2023, in addition to three special events-related STARCOM21 radio call downs. Participation from over 30 hospitals and healthcare partners in the planned STARCOM21 radio drills averaged 78% (ranging from 70-93%). Radio drills, call downs and follow-up increase communication and collaboration among HCC partners while building communication redundancy. Technical assistance is provided to partners when requested.

EMERGENCY OPERATIONS COORDINATION

Developing processes for notification and information exchange of healthcare delivery between relevant response partners, stakeholders, and healthcare organizations to determine immediate resource needs.

In order to assure emergency operations coordination during real and planned events, CDPH provides a linkage between HCC partners and City agencies through the City of Chicago Emergency Operations Plan.

Enhancements were made to the patient tracking system,

EMTrack™, and the EMResource™ information sharing platform.

The 213 Resource Request and the 205 Communication ICS forms and processes within EMResource™ were updated to improve the transparency of available and deployable resources. Training opportunities included in person hospital site visits and deployment of iPad technology to facilitate ease of patient tracking procedures.

Activation examples during special events include Lollapalooza, the Bank of America Chicago Marathon, and the Chicago Pride Parade. Real events include the ongoing COVID-19 response, New Arrival, Migrant response, Mpox vaccination campaign, the Pediatric Respiratory Surge, and Ebola Virus Disease monitoring.



MEDICAL SURGE

Assuring the readiness of the healthcare system to respond to an influx of ill or injured patients during incidents that exceed the limits of the normal medical infrastructure within the community.

Members of the HCC's Medical Surge Committee, chaired by the Regional Hospital Coordinating Center (RHCC) of EMS Region 11, contributed to the review and update of the Evacuation/Shelter-in-Place Annex, including more accurate documentation of hospital evacuation supplies and updated contact and appendix information. Additionally, after its creation, Medical Surge Committee members collaborated on updates to the newly developed Radiation Emergency Surge Annex.

As the surge of pediatric respiratory hospitalizations intensified throughout the Fall of 2022, the Medical Surge Committee met to share situational awareness and surge response resources. Monitoring and reporting pediatric bed availability in EMResource™ became a critical decision-making tool throughout the surge. Situational awareness and preparedness resources for Ebola, Marburg Virus Disease, and Mpox were also shared among Committee members throughout the year, and hospital members benefited from a site visit by representatives from the National Emerging Special Pathogens Training and Education Center (NETEC).

In preparation for special events and exercises, the Medical Surge Committee met regularly to share information and preparedness and response priorities. Hospital site visits were prioritized by level of resource need and health equity considerations to build EMResource™ and EMTrack™ capabilities among staff members, address preparedness gaps, and encourage HCC participation.



RESPONDER SAFETY & HEALTH

Developing, refining, and sustaining strategies to assist healthcare organizations with planning, equipping or training to meet preparedness goals.

The HCC has developed a protocol to facilitate the replenishment of pre-deployed disaster caches and promote emergency preparedness, mitigation, response and recovery capabilities of participating member organizations. Thirty-one hospitals and healthcare partners participated in the disaster cache purchase program where shelter-in-place, responder, and decontamination supplies were forward deployed. Supplies most frequently ordered were treatment cots for use during medical surge and PPE kits.

Additional responder safety supply caches were maintained at a centralized location in a ready state.

Pediatric responder supplies were forward deployed to the Chicago Fire Department Emergency Medical Services Division based on identified needs.
